
In continuation to this office order of even number dated 16/02/2024 on the subject cited above, it is stated that the 'Internal Complaint Committee' has been reconstituted vide this office order dated 18/03/2024 in terms of the provisions of Section 4(2) of the "Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act, 2013" to inquire into the complaints of sexual harassment.

In order to ensure effective implementation of the "Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act, 2013" and to bring uniformity in the composition of ICC at every unit of KVS, the competent authority, KVS (HQrs) New Delhi vide letter No.F. 11-55/2000-KVS(Vig.)/Pt.I/ dated 05/03/2019 has approved **the composition of the 'Internal Complaint Committee' and its jurisdictions at Vidyalaya Level as under:-**

3	Member	Not less than two members from amongst employees preferably committed to the cause of women or who have had experience in social work or have legal knowledge.	Principal, Vice Principal and HM

5	Member	One Representative from VMC (preferably lady member)
